SCOPE OF WORK

This auction encompasses all the following services:

- 1. Pickup and safe disposal of wastes from Radiology Dept. of ESIC Model hospital.
 - a. The categories for chemical waste to be disposed are as follows:

- b. The auction is for chemical waste and waste x-ray films pick-up. Waste is to be picked up within period of 15 working days after the issue of contract letter.
- c. The table above lists the categories of waste.
- d. The firm has to certify that they are quoting their best higher rates and they are not purchasing waste chemical/films higher than quoted in this auction from any other organization.

e. Vendor should always keep handy, and an up-to-date copy of the necessary approvals received from Central PCB or State PCB permitting them to collect and deal with hazardous waste to facilitate smooth waste safe disposal operations. He may have registration letter as a recycler with PCB.

f. An up-to-date copy of the approval letter from Central PCB or State PCB must be submitted to ESIC by the vendor at the time of submitting auction

documents and before collecting chemical wastes from ESIC.

g. Vendor should ensure the Transport Vehicles deployed and utilized for transportation of the Hazardous chemical wastes by the vendor should be road worthy, fit to carry such hazardous wastes as prescribed by statutory bodies such as UPSPCB and such other statutory bodies as prescribed from time to time, at their own costs.

h. Vendor should ensure that the vehicles are used exclusively for the transportation of hazardous chemical wastes, maintained in good condition and an alternative arrangement made in case of breakdown at their own

Vendor needs to collect empty barrels/containers/liners contaminated with

hazardous chemicals/wastes.

j. Vendor will be responsible for compliance of all statutory provisions relating to Provident Fund, and Employees State Insurance etc., in respect of its employees deployed for the purposes of collection, transportation and disposal of hazardous waste. In addition, vendor at their own cost provides all the necessary safety gear and equipment to undertake the said activities.

k. The vendor will be responsible for ensuring that all the personnel employed by them for the work follow all requisite safety and security regulations and instructions known to law as also the instructions that ESIC may issue as necessary to such personnel at the time they are within the premises of the

Institute for the purpose.

I. At the time of collection of hazardous chemical wastes/films from the Institute premises, Vendor shall ensure proper conduct and that they do not act in any way that may be detrimental to the interests of ESIC and cause any danger

within the premises of ESIC.

m. Vendor shall ensure that in case of an accident or any unforeseen events during transportation, the chemical waste should not be misused; the entire quantity shall be transferred to another vehicle and transported to their site safely at the cost of the vendor.

n. Gate pass will be issued after the collection of the waste chemicals from ESIC

office and security.

o. There is no guaranteed number of chemical wastes that must be disposed via the rate contract. The disposal is subject to availability.

p. Vendors need to obtain all additional licenses, permits, consents, sanctions etc. as may be required or called for from/by local or any other authority for undertaking such work or in furtherance to this agreement.

q. Vendor shall comply with all applicable laws, rules, and regulations in force. Vendor should undertake to produce the licenses /permissions etc., so obtained to ESIC or furnish copies thereof as and when required by ESIC.

OTHER DETAILS

 The chemical wastes are of different category: chemical waste – developer & fixer of x-ray with their containers and waste x-ray films.

The pickup of chemical waste is to be done from ESIC campus. The chemical waste must be picked directly from the department where they are currently stored during office hours: Usual pick-up hours are between 10:00 am to 3:00pm on working days.

The pick-up and safe disposal of chemicals waste must be as per standard SOP, following all regulatory and safety precaution.

2 Submission of bid

The bids must be submitted in a closed Envelope. Envelop shall be superscribed, "QUOTATION for Collection & Safe Disposal of chemical wastes/x-ray films from ESIC MEDICAL COLLEGE & HOSPITAL, SECTOR-24, NOIDA-201301". The bidder will submit the proposals on the letter head of company.

SUCCESSFUL VENDOR/BIDDER QUALIFICATIONS

- The bidder with highest price quote (H1) will be successful and awarded the contract for pickup of the chemical waste/ waste x-ray films.
- The successful tenderer will have to deposit full value of the Waste materials in advance in ESIC FUND A/C NO 1 before lifting the waste.
- 3. No EMD is required for applying in the auction. No reserve price is set for the auction.
- 4. Agency should have been in the business for minimum 03 years. This period of 03 Years in business should have been completed on the date of application. Proof for previous three years for services provided to any Institution preferably PSUs/PSBs should be submitted along with a report of satisfactory service from them.
- The vendor must have regulatory approval for safe disposing of chemical wastes.Documentation to support this must be provided.
- The vendor must demonstrate prior experience of handling chemical wastes. A set of previous POS or invoices should be provided. Experience of safely disposing chemical wastes is mandatory.
- Vendor must not be blacklisted by any institution of the Central or State Govt. / PSU/PSB in the past three years on any grounds whatsoever. MSMEs can seek an exemption to some qualification criteria.

DOCUMENTS TO BE SUBMITTED:

- Authorization letter/Registration letter with regards to collection/disposal of hazardous chemical waste/x-ray films from center of state government pollution control board.
- An undertaking to be submitted with regard to Waste management rules 2016 or any updated such rules.
- An acceptance certificate that he has gone through the terms and conditions mentioned above and undertake to comply with them.
